The Pendulum Risk Management Resource Center is an online portal that allows subscribers to access numerous documents to assist the facility Administrator or clinician in the management of risk in the healthcare setting.

Examples of the types of information found on the Resource Center include:

- Assessment forms and checklists
- Shared risk agreements
- Arbitration/mediation agreements
- Sample clinical policies and procedures for both skilled nursing and assisted living levels of care
- Best practices
- Regulatory guidelines (including a fully searchable copy of OBRA regulations)
- Survey management tools
- Health Insurance Portability and Accountability Act (HIPAA), Occupational Safety and Health Administration (OSHA), and U.S. Food and Drug Administration (FDA) guidelines
- Risk-reduction recommendations

Many of the tools on the Resource Center are user-friendly Word documents that may be downloaded, customized, and used within a facility immediately.

The Pendulum Risk Management Resource Center is updated regularly to ensure subscribers are viewing current information on issues and trends in the healthcare setting. Subscribers are notified via email when significant documents are uploaded to the Resource Center.

eAssist[®] allows a subscriber to ask a clinician a question regarding any area of risk management in the healthcare setting and receive a direct response. Frequently asked questions (FAQs) are also a reference for users.

The Resource Center also allows subscribers to follow the status of key healthcare legislation. Users can see when a bill was introduced, the bill's sponsor, status details, and any current action on the bill. Users can also view news and blog coverage of the bill.

The calendar feature of the Resource Center lists important dates for the senior housing industry, including conventions and governmental deadlines.

An annual subscription to the Resource Center includes unlimited users within a single facility.
