#### **Understanding the Report**

The article goes on to state that the Department of Public Health found that "on the day of the assault, the staff failed to make its required checks of the second resident every 15 minutes."

#### **Appendix A: Media-type Definitions**

#### Aggregator

An aggregator is a website or type of software that collects published content or data from other sources. Some aggregators publish content without permission and without citing the original author. Other aggregators exist to collect information from many websites into one place, with proper citations as a matter of convenience for users.

#### Blog

A blog is a website that is updated regularly with posts related to a specific topic or theme, incorporating images, links, video, and other media. Blog posts tend to be less formal than news articles or similar media and often, but not always, serve as personal journals of the blog writer (or "blogger"). In the comments section of a blog, readers can interact with each other and the blogger. Many blogs have large communities of readers and active comment-board participants.

#### Buy/Sell

Buy/Sell websites promote products and services for sale via advertisements or classified listings.

#### Forums/Message Boards

Forums and message boards are places where online communities gather to hold discussions on specific areas of interest.

#### Images

Images are used to create more visual interest or supplement information on websites. Image-sharing communities of professional and amateur photographers have developed on websites like Flickr, Instagram, and Photobucket.

#### **Mainstream News**

Major news outlets, including television networks and newspapers, provide frequent news updates online. They utilize articles, videos, or a combination of the two to present information. In addition, many have their own blogs. Visitors can discuss news items in public comment sections.

#### Micromedia

Micromedia sites, the most recognizable example of which is Twitter, are characterized by short, frequent bursts of information posted by a large network of users. These websites emphasize the sharing of links, videos, and photos. They are gaining in popularity as mobile technology becomes more widely available.

#### Social Networks

Social networks, such as Facebook and LinkedIn, are websites that allow people to connect with friends, family members, professional contacts, etc. online. #### **Rating Website**
